Please pay your dues promptly. If dues remain unpaid for one year, a lien will be placed on the property and assessed an additional \$25 recording fee.

If a prior Homeowner fails to pay dues to their required annual NCHA dues, it is still a liability on that Nelson's Creek lot. The NCHA Covenants create a legally collectable debt on each lot in the subdivision. As such, it is the responsibility of each new Homeowner to verify their dues are paid up and current.
