

**MINUTES OF MEETING**  
**OF**  
**SANITARY AND IMPROVEMENT DISTRICT NO. 337**  
**OF DOUGLAS COUNTY, NEBRASKA**

A meeting of the Board of Trustees of Sanitary and Improvement District No. 337 of Douglas County, Nebraska, was convened in open and public session at 8:00 p.m. on the 13th day of April, 2011, at Picotte Elementary School, 14506 Ohio Street, Omaha, Nebraska.

Present were: Thomas L. Rerucha, Janet T. Pol, Bill Fleck and Joe Temme. Also attending the meeting was James D. Buser, attorney for the District.

Absent: Joan C. Lubisher.

Notice of the meeting was given in advance thereof by publication in The Daily Record on April 7, 2011, a copy of the proof of publication being attached to these minutes. Notice of this meeting was simultaneously given to all members of the Board of Trustees, and a copy of their acknowledgment of receipt of notice is attached to these minutes. Availability of the agenda was communicated in the published notice and in the notice to the Trustees of this meeting. All proceedings of the Board were taken while the convened meeting was open to the attendance of the public. The agenda was at all times available at the office for the District at Regency Center, 10250 Regency Circle, Suite 300, Omaha, Nebraska.

The undersigned Clerk hereby certifies that these minutes were written and available for public inspection within ten (10) working days after the date of such meeting. The meeting was called to order.

It was first publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy in the room where the meeting was being held.

There were next presented miscellaneous bills, invoices, statements, and recommendations for the Board's consideration.

There was next presented a statement from The Cutting Edge Lawn Care Inc., per the Maintenance Agreement with the Nelson's Creek Homeowners Association, for mowing and trimming of Outlots 1 & 4 for 2011 mowing season, Invoice #16, in the amount of One Thousand and no/100 Dollars (\$1,000.00).

There was next presented a statement from Great Plains One-Call Services Inc., for line locates, Invoice #211SD337, in the amount of Three and 58/100 Dollars (\$3.58). The Board next directed an advance payment to be made in the amount of One Hundred and no/100 Dollars (\$100.00).

There were next presented statements from Lamp, Rynearson & Associates, Inc., engineers for the District, for services rendered in miscellaneous District matters through March 19, 2011, as follows: (i) Invoice dated March 11, 2011, in the amount of One Hundred Five and 91/100 Dollars (\$105.91), and (ii) Invoice dated April 8, 2011, in the amount of Two Hundred Thirty-Four and 16/100 Dollars (\$234.16); said statements being in the aggregate amount of Three Hundred Forty and 07/100 Dollars (\$340.07).

There was next presented a statement from Pansing Hogan Ernst & Bachman LLP, attorneys for the District, for legal services rendered in miscellaneous District matters through March 31, 2011, in the amount of One Thousand One Hundred Twenty-Eight and no/100 Dollars (\$1,128.00), and costs advanced in the amount of Sixty and 84/100 Dollars (\$60.84); said statement being in the aggregate amount of One Thousand One Hundred Eighty-Eight and 84/100 Dollars (\$1,188.84).

There was next presented a statement from Omaha Public Power District, for street lights at the service location of 14400 Erskine Street, from February 25, 2011, through March 30, 2011, in the amount of Two Thousand Four Hundred Three and 69/100 Dollars (\$2,403.69).

The previously described bills, invoices, recommendations and statements having been presented for the Board's consideration and after review and discussion of such items and upon a motion duly made and seconded, and upon the following roll call vote, the Trustees, Thomas L. Rerucha, Janet T. Pol, Bill Fleck and Joe Temme voted "Aye" with none voting "Nay" thereby passing and adopting the following resolutions:

RESOLVED, by the Board of Trustees of Sanitary and Improvement District No. 337 of Douglas County, Nebraska, that the Chairman and Clerk be and they hereby authorized and directed to execute and deliver Warrant Nos. 3627 through 3631 of the District, dated the date of this meeting, to the following payees and in the following amounts, said Warrants to be drawn on the General Fund of the District and to draw interest at the rate of six and a half percent (6.5%) per annum and to be redeemed no later than April 13, 2014, subject to extension of said maturity date by order of the District Court of Douglas County, Nebraska, after notice is given as required by law, to-wit:

Warrant No. 3627, for the amount of One Thousand and no/100 Dollars (\$1,000.00), payable to The Cutting Edge Lawn Care Inc.

Warrant No. 3628, for the amount of One Hundred and no/100 Dollars (\$100.00), payable to Great Plains One-Call Services Inc.

Warrant No. 3629, for the amount of Three Hundred Forty and 07/100 Dollars (\$340.07), payable to Lamp, Ryneanson & Associates, Inc.

Warrant No. 3630, for the amount of One Thousand One Hundred Eighty-Eight and 84/100 Dollars (\$1,188.84), payable to Pansing Hogan Ernst & Bachman LLP.

Warrant No. 3631, for the amount of Two Thousand Four Hundred Three and 69/100 Dollars (\$2,403.69), payable to Omaha Public Power District, Account #3893100011.

FURTHER RESOLVED by the Board of Trustees of Sanitary and Improvement District No. 337 of Douglas County, Nebraska, that both they and the district hereby find and determine and covenant, warrant and agree as follows: the improvements and/or facilities being financed or refinanced by the above Warrants are for essential governmental functions and are designed to serve members of the general public on an equal basis; all said improvements have from the time of their first acquisition and construction been owned, are owned and are to be owned by the District or another political subdivision; to the extent special assessments have been or are to be levied for any of said improvements, such special assessments have been or are to be levied under Nebraska law as a matter of general application to all property specially benefited by said improvements in the District; the development of the land in the District is for residential or commercial use and the development of the land in the District for sale and occupation by the general public has proceeded and is proceeding with reasonable speed; other than any incidental use of said improvements by a developer during the initial period of development of said improvements, there have

been, are and will be no persons with rights to use such improvements other than as members of the general public; none of the proceeds of said Bonds or any refinanced indebtedness have been or will be loaned to any private person or entity; the District hereby authorizes and directs the Chairperson or Clerk to file or cause to be filed, when due, an information reporting form pursuant to Section 149(e) of the Internal Revenue Code of 1986, as amended, pertaining to the above Warrants; and the District does not reasonably expect to sell or otherwise dispose of said improvements and/or facilities, in whole or in part, prior to the last maturity of the above Warrants.

FURTHER RESOLVED by the Board of Trustees of Sanitary and Improvement District No. 337 of Douglas County, Nebraska, that the District hereby covenants, warrants and agrees as follows: (a) to take all actions necessary under current federal law to maintain the tax exempt status (as to taxpayers generally) of interest on the above Warrants; and (b) to the extent that it may lawfully do so, the District hereby designates the above Warrants as its "qualified tax exempt obligations" under Section 265(b)(3)(B)(i)(III) of the Internal Revenue Code of 1986, as amended, and covenants and warrants that the District does not reasonably expect to issue warrants or bonds or other obligations aggregating in the principal amount of more than \$5,000,000 during the calendar year in which the above Warrants are to be issued.

FURTHER RESOLVED, by the Board of Trustees of Sanitary and Improvement District No. 337 of Douglas County, Nebraska, that this and the preceding Resolutions are hereby adopted as the Certificate With Respect to Arbitrage of the District pertaining to the above Warrants and the District and the Chairman and Clerk of the District hereby further certify, as of the date of the registration of the above Warrants with the County Treasurer of Douglas County, Nebraska, as follows:

1. No separate reserve or replacement fund has been or will be established with respect to the above Warrants. The District reasonably anticipates that monies in its Bond Fund reasonably attributable to the above Warrants in excess of the lesser of: (a) ten percent (10%) of the net principal proceeds of the above Warrants, (b) the maximum annual debt service due on the above Warrants, or (c) one hundred twenty-five percent (125%) of average annual debt service due on the above Warrants will be expended for payment of principal of and interest on the above Warrants within thirteen (13) months after receipt of such monies. That amount which is currently held in the District's Bond Fund which exceeds the amount which is to be expended for payment of principal and interest on the above Warrants within thirteen (13) months after receipt of such monies, plus that amount arrived at pursuant to the immediately preceding sentence, will not be invested in any securities or any other investment obligations which bear a yield, as computed in accordance with the actuarial method, in excess of the yield on the above Warrants.

2. To the best of their knowledge, information and belief, the above expectations are reasonable.

3. The District has not been notified of any listing of it by the Internal Revenue Service as an issuer that may not certify its bonds.

4. This Certificate is being passed, executed and delivered pursuant to Section 1.148-2(b)(2) of the Income Tax Regulations under the Internal Revenue Code of 1986, as amended.

There was next discussion amongst the Trustees regarding replacement of street signs within the District that have deteriorated. Mr. Fleck distributed some materials for review by the Board of Trustees. No decision was made on potential replacement and the issue was tabled for further discussion.


